Important Points:

- 4. In the ICAI Commerce Olympiad, the Counsellor shall register the students at least 40% from each counselling session. There is no fee charged from the students.
- 5. The Career Counsellors shall not publicize the credentials or any sort of

canvasing for the Coaching classes or centers in the aforesaid career Counselling programmes.
